The OSCE Mission to Skopje ("the OSCE") invites Bids ("Bids") from eligible and qualified companies ("the Bidders") for the Supply, Fitting, Repair and Storage of Vehicle Tyres and Associated Services ("the Services"), according to the requirements as defined in the bidding documents ("the Bidding Documents").
