This is an estimate and not a guarantee of volume of sales which is subject to organizational needs throughout the contract lifetime.
2	Administrative	Annex D - Terms of Reference	Delivery period noted is for up to 50 items of PPE to be within six weeks to FCA, is this correct?	Yes this is correct, details in the ITB outline this requirement for up to 50 items of PPE within six (6) weeks to FCA.

Given the range in sizes requested is from 'Small' up to 'XXX Large' the itemization is to allow bidders to provide a price to cover all sizes if there is a price variance.

The ITB will be updated to provide clarity in this regard. Bidders should confirm if they can deliver to the VIENNA location only. An indicative price is requested but optional. It is understood these are not fixed prices for the duration of contract but are indicative and subject to change over the course of the contract.
