

## **Clarification Note #1**

## Request for Quotation (RFQ) No. PR 621169 - Supply and delivery of equipment and accessories to create a multimedia distant-learning classroom in the Palladin Institute of Biochemistry (Kyiv, Ukraine)

In accordance with issued RFQ No. PR 621169 - Supply and delivery of equipment and accessories to create a multimedia distant-learning classroom in the Palladin Institute of Biochemistry (Kyiv, Ukraine), the OSCE would like to provide the following clarifications to the RFQ Documents:

## LOT 4 - Air conditioners and installation services

**Question 1:** To understand the upcoming scope of work and, accordingly, its cost, could you clarify the following:

- 1) Locations of outdoor and indoor units of air conditioners to determine the length of the Freon line.
- 2) Place of drainage outlet (bathroom, street, storm drain, etc.).
- 3) Is there access from the window to the installation site of the outdoor units or is it necessary to order lifting mechanisms or invite industrial climbers?
- 4) Should power supply be from the panel or from the nearest outlet?
- 5) What is the length of the decorative box for the Freon line (if necessary)?
- 6) Any other additional work or installation conditions.

Answer 1: The answers are below. Pictures with indicated places of installation are provided in Annex A at the end of this document.

- 1) See Annex A, the places of installation of outdoor and indoor units of air conditioners are marked with a red cross.
- 2) Place of drainage outlet street.
- 3) Installation is on the 1st floor, there is an access and possibility of using a regular staircase.
- 4) Power supply from the panel (electrical distribution box). In room 105, there is a panel in the room, in 103 - in the corridor. Electric cable shall be covered with decorative box.
- 5) Decorative box for Freon line is not needed.
- 6) Power supply should be installed with the cable from the panel.
